# Proposed Changes, Revisions, or Additions to the DEAC Standards of Accreditation

The Commission voted to explore whether it is appropriate for DEAC to pursue the inclusion of PhD programs within the scope of its accreditation activities and plans to design a pilot study to develop and test appropriate accreditation standards and procedures. DEAC currently has professional doctoral degrees within its CHEA and USDE-recognized scope of accreditation. By comparison, the PhD is a research-oriented doctoral program designed to prepare students for high level scholarly work. The PhD emphasizes the acquisition, organization, utilization, and dissemination of knowledge. A PhD program must afford the student the opportunity for substantial mastery of the subject matter, theory, literature, and methodology of a significant field of study. This includes a sequential development of research skills leading to the attainment of an independent research capacity. PhD dissertations require original research that contributes to new knowledge in the chosen field of study.
